The cost to us would be approximately \$100 for the installation, internet service per month is \$80, phones are \$20. Both have a promotional discount attached. No discount for internet is \$130/month, phones are \$50/month. We would stick with 186 Networks for phone service. We are going to look for our own wireless router that will work with our directional antennas. We are set to add the grandstand building with this construction and can add the maintenance barn in the future if we need to.

- a. Frank Reviewed vendors for fair. Radios and tents are in process. Frank is working with 4Hers to get the horse stalls put up at the work bee.

- e. Laurie 80% complete with premium book. Just need to get the ShoWorks numbers. Expect the book to be done by the end of the month. Animal registration deadlines July 1 and non-animal 12th of July. Haven't heard back from MDARD regarding the grant yet. The person building the quilt rack has looked at the space in the Heim Building.
- f. Al The Avian flu is staying away from us so far. The flu in Bovine is still TBD. Regarding the animal abuse at fair last year, Al shared a message he received from Autumn from the MSU committee working on preventing animal abuse. Many fairs are having issues getting judges and that includes us. We may need to review our policies on hiring judges.

- i. Clarissa Parade season is starting soon. Reviewing the summer schedule with our fair queen.
- j. Milt Had someone with a relic that we may want to add to the museum from 1887. Gets sponsors to Milt for the website. Winter storage pulling out campers for the next 3 Sundays.
- k. Carolyne Reviewed sponsors as of 4/9/24. Shared wood plaques made by Charlie Browne. They are \$20 each, would like to do these for our sponsors.
- I. Cody Sending out a group text for entertainment committee for a meeting.
- m. Tom ShoWorks 2024 has been activated and installed on a virtual machine running Windows 11 on Microsoft Azure. We have a trial subscription of 750 hours, \$200 or 30 days. The database from 2023 has been migrated to the 2024 database with the exceptions of the entries. A link to the virtual machine has been placed on the office desktop. One person at a time can use the virtual machine, this should be sufficient for our current needs. We used only 1 computer for the last few years. Working on trying to get sponsors for banners. Also was approached about a sponsorship for dust control. How many gallons were used in previous years? 10,000ish gallons for fair week only. 3500 gallons minimum for additional treatments during the summer. We can pay for the smaller amounts in combination with the sponsorship.
- n. Joe Molon was here doing dirt work. The dirt area does include the area for the light poles. We will be adding fabric and stone to eliminate some mowing. We did receive preliminary prints but need a few changes. Working on getting power restored to the fuel tanks. Looking at turning the water on during the last week of April. Bleachers will be here the first part of June. Molon Asphalt would like to come in during the first part of May to edge the asphalt and then seal it. Elmer's would like to come back for their company party again this year. They would like to use our grandstands this year.
